# World Hovercraft Championships, 2010

As agreed at our last Board meeting we are intending to hold our next World Championships in 2010. So far we have only had an offer to host the event for us from Germany. Unless any other country comes forward within the next two months we will be accepting Germany's kind offer.

# Changes to WHF Competition Regulations.

Early in December your representative was asked to vote on the changes which were discussed in outline at our last Board meeting and explained in detail in a subsequent paper.

The results of the votes were as follows:

Proposal:	I agree	I disagree

C). Proposal to change Formula 25:	UK, Indonesia, Italy, Sweden, Ireland, Netherlands, Canada	USA, Germany
D). Proposal re Formula 3:	Italy, Sweden, Germany, Ireland, France, Canada	UK, USA, Indonesia, Netherlands

#### This means that:

# • Formula 2:

Formula 2 is re-defined as under 600cm3 two stroke or under 750cm3 four stroke. Where the lift is provided by a separate engine, the capacity allowed for the lift engine may be multiplied by 2 if the lift engine and fan is in direct transmission (e.g. fan directly on the lift engine crank shaft). Engines are classed according to the standard cm3 when new. Re-bores for maintenance are allowed to the following oversize: 610cm3 two stroke and 768cm3 four stroke.

# • Formula 1:

As a result of the change to Formula 2, Formula 1 will be redefined as 600 cm<sup>3</sup> two stroke and over or 750 cm<sup>3</sup> four stroke and over.

(For both Formula 1 & 2 where a craft has a combination of two and four stroke engines the total capacity shall be determined by dividing the capacity of the four stroke by 1.25 and using the two stroke capacity).

#### • Endurance Racing (ER):

Where ever possible ER will be included at all future World Championships.

#### • Formula 25:

Formula 25 (25 horse power four stroke) will be replaced with Formula 35 (35 horse power four stroke). The precise engine(s) definition for Formula 35 has still to be agreed but will be published within the next three months.

Formula 35 will be run within ER but their points will be extracted for a Formula 35 Championship. Where it is not practical to hold ER a separate series of Formula 35 races will be held.

### • Formula 3:

Formula 3 as currently defined will be removed from future World Hovercraft Championships.

These changes will take effect immediately and therefore will apply at our next Championships. As soon as the precise engine(s) definition for Formula 35 has been agreed this and the new formula definitions will be included in the WHF Competition Regulations and re-issued.
