# **Registrations:**

- Registration for the Championships has now closed, and we have been advised by the organizers that no further entries can be accepted.
- The Organizers have also given us details of registration so far and compared these with their initial estimates. These are as follows:

	Estimate	Today
Drivers	120	161
Craft in Paddock	120	150
Camping – Motor homes	60	87
Camping – Tents	80	137
Formulae requiring heats	2	3
Meals on Saturday evening	400/500	550/600

• On one hand this is a tremendous response and will make for a fantastic Championship, on the other hand it will stretch the Organization to the limit and will demand patience from all.

# **Restriction of Formula Entries:**

• As mentioned in Bulletin 13 it is almost certain that drivers who have registered in both F50 and FS with the same craft will be excluded from FS. This will reduce the need for heats in FS. Regrettable as this may be it is the only way for the Organizers to arrange a sensible race programme.

### <u>Please help the Organizers</u>.

### Payment and on site registrations

• <u>All</u> payments (in euro cash) and racing document inspection / personal registration must be made no later than Tuesday 22<sup>nd</sup> August. This includes non-driver meals. (The correct number of meals will be ordered last thing Tuesday evening and it will not be possible to add meals after this).

## Arrival on site:

• Camping on site will **not** be permitted until Sunday 20<sup>th</sup> of September and not as previously indicated.

### WHF Board pre - meeting:

- You will see the Agenda for the formal WHF Board meeting on Monday is getting very long. We know that a lot of people will be leaving Monday afternoon to return home again. We suggest having a short extra meeting on Wednesday evening on the 23<sup>rd</sup> of August, on site in the VIP square, from 19.00 till 20.00 hours.
